Legislation Report



PAIN AT THE PUMP

On March 23rd, Governor Gavin Newsom proposed a gas rebate for the State of California. With the average price at \$5.88 per gallon (and climbing) according to AAA, which is \$2.00 higher than last

year. California has the second highest gas tax in the country at \$.51 per gallon. Proposed is \$523 million to halt a scheduled increase in the state's gas tax this summer.

Newsom's plan is similar to a separate proposal floated last week by moderate Democrats in the State Assembly that would give every tax payer \$400 per vehicle, up to two vehicles per person, (including electric cars) regardless of income. Eligibility is based on vehicle registration, not tax records, in the form of a debit card. Legislators are negotiating the details and if approved, the first debit card payments could be issued by July.

For those without cars, Governor Newsom wants the state to pay for their bus or train fare for three months. This proposition would give \$750 million to transit and rail agencies, which Newsom said would be enough to give three rides to three million people per day.

Another \$2 billion is designated to go toward other things such as free public transportation for three months, a pause on inflation adjustments to gas and diesel excise tax rates and incentives for bike and walking projects throughout the state.
