Legislation Report



January, 2022

California's Division of Workers' Compensation (DWC) announced the 2022 minimum and maximum temporary total disability (TTD) rates will increase on January 1, 2022. Temporary disability payments are calculated

at two-thirds of the employee's "average weekly earnings" up to a maximum amount, which changes every year based upon a cost of living adjustment. California Labor Code 4453(a) (10) requires that the TTD rate increase by an amount equal to the percentage increase in the State Average Weekly Wage (SAWW) as compared to the prior year. The SAWW is the average weekly wage in California paid to employees covered by unemployment insurance for the twelve months ending March 31st in the year preceding the injury, as reported by the U.S. Department of Labor. The minimum TTD rate will increase to \$230.95 (from \$203.44) and the maximum TTD rate will increase to \$1539.71 (from \$1356.31)...
